NATIONAL NUCLEAR REGULATOR ACT, 1999 (ACT No. 47 OF 1999)

NOTICE IN TERMS OF SECTION 28 OF THE NATIONAL NUCLEAR REGULATOR ACT,
1999 (ACT No. 47 OF 1999), ON FEES FOR NUCLEAR AUTHORISATIONS

Under section 28 of the National Nuclear Regulator Act, 1999 (Act No. 47 of 1999), I B. P. Sonjica, Minister of Minerals and Energy, on the recommendation of the Board of Directors of the National Nuclear Regulator and in consultation with the Minister of Finance, hereby determine in the Schedule, the fees payable to the Regulator in respect of-

- (a) any application for the granting of a nuclear authorisation;
- (b) an annual nuclear authorisation fee for the financial year 2006/2007.

SCHEDULE

Definitions
